## Partner with Us to Promote DEA Drug Take Back Day

Observance Presents Opportunity for SOS Partners

As members of the State Opioid Stewardship Program, we appreciate the leadership you have shown in helping to reduce the amounts of prescription opioids circulating in Kentucky. Yet, we must continue to help make our communities safeer by disposing of unused medication. As leaders in prescription opioid safety, promoting events like this Spring's DEA Take Back event can help make an impact in improving prescription safety across Kentucky.

While the issue of unused prescriptions might seem harmless to some, the truth is these leftover medications pose a serious risk to the health and safety of our family, friends, and communities. In fact, in 2019, 50% of those who misused prescription pain relievers in the past year said that they obtained the pain relievers from a friend or relative. This is in comparison to 35% who obtained their pain reliever from a doctor and 6% who bought from a stranger (National Survey on Drug Use and Health, 2018).

Child safety is also at risk. In the state's most recent child fatality/near fatality report, statistics show the leading cause of child neglect in case investigation findings is accidental

overdose/ingestion – typically the result of environmental neglect, when prescribed or illegal drugs are left accessible to children.

SOS facilities can be leaders in helping to promote resources to help people safely rid their homes of unused prescription medications, including prescription opioids. Here are some sample messages to promote at your facility, with local media, your website, and social media platforms. Social media graphics have been created for the April Take Back promotion, with Kentucky-specific messaging. These images can be downloaded and shared <a href="here">here</a>.

- Prescription drop boxes are available across Kentucky in conjunction with law enforcement agencies and local governments. There are now over 200 locations in 116 counties, with sites being added daily.
- Simply go online to the <u>DEA's designated website</u> or a <u>Kentucky-specific page</u> created by the Office of Drug Control Policy. Scroll to the collection site locator and type in a ZIP code or other locality information.
- For individuals experiencing transportation or access issues, consider promoting the
  use of drug disposal bags. These can be <u>purchased online</u> or obtained from a
  pharmacist, and are easy to use.
- Prevention and safety are just as critical to opioid response as treatment and recovery
   and it is the area where nearly every Kentuckian has the chance to make an impact.

## **Post-Partum Opioid Dispensing in Kentucky**

Kentucky has a decade's long history of substance use disorder in its citizens. As the statewide and national opioid crisis continues, to combat this problem, one strategy as a commonwealth has been to examine opioid prescribing in the healthcare setting.

The Cabinet of Health and Family Services' (CHFS) Office of the Inspector General (OIG) and the Kentucky Perinatal Quality Collaborative (KyPQC) quantified the level of opioids dispensed to postpartum women in Kentucky in the first seven days following uncomplicated deliveries among primigravida (first time) mothers. Primary outcome measures included the days supply of the opioid prescriptions, as well as the metric quantity and overall morphine milligram equivalent (MME) load per prescription.

A review by Dr. Adam Berrones of KASPER (Kentucky All Schedule Prescription Electronic Reporting) data housed in OIG from 2014 to present, uncovered a high level of opioid analgesic prescriptions dispensed in this population that far exceeded the American College of Surgeons Expert Panel Consensus. Adhering to these expert guidelines by Johns Hopkins University are key, as appropriate opioid prescribing for women having uncomplicated child deliveries could

mitigate the incidence of substance use disorder in a relatively vulnerable population: Kentucky women who are opioid naïve.

Although this KASPER data review showed significant decreases over time, the average MME for both spontaneous vaginal delivery and cesarean sections among Kentucky resident mothers, at the present time, are at levels that are inconsistent with the expert recommendations.

CHFS will be collaborating closely with CEOs and Chief Nursing Officers with the end goal of more closely aligning their opioid prescribing patterns with current recommendations. Adam Mather, the Inspector General, and the medical advisor of KyPQC, Dr. Connie White, thus began conducting outreach initiatives with hospitals who had the highest (average) levels of MME. In addition, Pharmacist Consultants with the Drug Enforcement and Professional Practices Branch in OIG, began meeting directly with providers to discuss their prescribing patterns.

The CHFS team will present more of these data at the KHA Annual Meeting on May 17 at 3:30 to give more details about this project.

### FindHelpNowKY.org adds resources, options for Deaf/Hard of Hearing community

For those who are Deaf, Hard of Hearing, or DeafBlind, there is often a lack of understanding between those with and without hearing loss and, many times, providers don't grasp what is truly involved in providing culturally affirmative and linguistically accessible treatment.

However, thanks to a partnership between near-real-time substance use disorder treatment locator <a href="FindHelpNowKY.org">FindHelpNowKY.org</a> and the Deaf and Hard of Hearing Services program at the Kentucky Division for Behavioral Health, Developmental and Intellectual Disabilities, the website now offers information in American Sign Language and has resources specifically created for the diverse linguistic community.

Through the partnership, enhancements were created to the Population Served and Languages Supported sections of FindHelpNowKY.org so that treatment facilities can designate that they can accommodate the needs of Deaf or Hard of Hearing clients. The resources section of FindHelpNowKY.org also now includes a video in ASL that explains how to use the website. The

video is available on <u>FindHelpNowKY.org</u> and the <u>FindHelpNowKY</u> YouTube channel and has been linked to additional partner sites such as the Hearing Loss Association of America.
