Hospital Quality Improvement Contract (HQIC) Webinar

Topic: Improving Opioid Stewardship across the Surgical Continuum Dr. Thomas Mark, anesthesiologist with Summa Health in Ohio, will provide details as to the results achieved through aggressive opioid stewardship efforts. Strategies to eliminate the need for opioids in every phase of surgery in addition to pain management treatment have been successful while maintaining patient satisfaction, achieving shorter lengths of stay and reducing readmissions.

Following Dr. Mark, Christine Bailey, MSN, RN, CSSGB, Executive Director with Health Services Advisory Group (HSAG) HQIC will provide insights as to how their quality improvement efforts have been influenced by this outstanding approach to foster improvements in opioid management in their supported hospitals.

September is National Recovery Month

National Recovery Month is an observance held every September to celebrate people in all forms of recovery and those who serve them. KORE is teaming up with representatives from Recovery Community Organizations, Department for Behavioral Health, Department of Corrections, Office of Drug Control Policy, Kentucky Hospital Association, and public health to promote this year's theme, Recovery is for Everybody: Every person. Every Family. Every Community. This message reminds us all that no one is alone in the journey through remission and recovery. Everyone's journey is different, every Kentuckians deserves recovery, and we are all in this together.

Events and social media promotional materials will be released later this month. To stay up to date on events and messaging, like us on Facebook, @KYOpioidResponse or email Beth.Fisher@Ky.gov. We encourage all organizations to celebrate Recovery Month in their communities as well. If you are looking for ways to celebrate recovery, here a few tips;

Use person first language like 'person in long-term recovery' and avoid stigmatizing terms like 'addict' or 'clean'.

Collect recovery stories of hope and healing and share them via social media or at community events.

Promote community resources. This can be done via social media or in person via flyers, pamphlets, and or other promotional materials.

Host a panel discussion to talk about recovery, including recovery testimonials as well as programs and services in your area. This can be done virtually using platforms such as Zoom or Microsoft Teams, or via social media platforms like Facebook and Instagram Live.

Host a public event, such as a "Recovery Rally" or a "Walk for Recovery" featuring speakers and entertainment.

Create a social media hashtag specific to your community and/or organization. Encourage members of your organization to join in by creating their own Recovery Month posts or testimonials.

Remember recovery is for everyone – individuals, families, and communities. Don't be afraid to reach out to schools, community-based organizations, and faith-based groups. They are key members of the community and can play a significant role in your Recovery Month promotion as well.

International Overdose Awareness Day

International Overdose Awareness Day is a global event held on August 31 each year and aims to raise awareness of overdose and reduce the stigma of a drug-related death. It also acknowledges the grief felt by families and friends remembering those who have died or had a permanent injury as a result of drug overdose.

International Overdose Awareness Day spreads the message that the tragedy of overdose death is preventable.
