New Program Aims to Make Naloxone Accessible to All Kentuckians

Kentucky Naloxone Co-Pay Program Covers Majority of Costs to Obtain Medication Naloxone – the medication used in the reversal of opioid-related overdoses – just became more accessible for Kentuckians through a new program that helps cover costs for insurance copayments.

The Kentucky Opioid Response Effort (KORE) and Kentucky Pharmacists Association (KPhA) have partnered to launch the Naloxone Co-Pay program to provide financial support for Kentuckians whose insurance plans do not cover the full cost of a naloxone prescription. Under the program, patients with commercial insurance may have their naloxone prescription copay reduced by up to \$60, meaning their cost for naloxone may be little as \$0 at their local pharmacy.

"Naloxone saves lives. Together with Kentucky Medicaid, which covers most naloxone products at no charge to the patient and the statewide standing order for naloxone, the accessibility of overdose reversal agents is dramatically improved" said Dr. Katie Marks, Project Director for KORE. "Often, obtaining the medication from a pharmacy results in expensive co-payments. This program will help more people access naloxone by making it more affordable or, in many cases, free."

Under the program, participants receive a naloxone co-payment card that can be utilized by the pharmacist to obtain a reimbursement from KORE. The maximum benefit is \$60 per naloxone prescription. Each patient may fill a prescription using the program once every 30 days or as determined by their health insurance plan. Kentuckians can access more information about the program as well as downloadable and printable copies of the card at www.kphanet.org/copay.

No registration is required, simply present the card to your local pharmacy with a valid prescription for naloxone. At many pharmacies across Kentucky you do not even need to bring a prescription with you as the pharmacist can issue one as part of a naloxone protocol prescribing program. Check with your local pharmacy to see if they have the ability to issue naloxone prescriptions directly. Pharmacy participation may vary, but the vast majority of pharmacies in Kentucky should be able to process the copay card.

Most FDA-approved naloxone products used for the reversal of opioid overdose are included, such as;

- 1. Narcan Nasal Spray
- 2. Kloxxado
- 3. Zimhi
- 4. Generic naloxone products when available and as preferred by their insurance

"Naloxone is safe, easy-to-use, and is the most powerful tool we have in directly preventing overdose deaths," said Jody Jaggers, Director of Pharmacy Public Health Programs, KPhA. "I encourage everyone to take advantage of the program so that we are better equipped as a state to respond to emergencies within our homes and communities. Overdose is tragically common and, with the growing prevalence of illicit fentanyl, a risk for too many Kentuckians." KORE and the Kentucky Office of Drug Control Policy partners with KPha and the Kentucky Department for Public Health to make naloxone accessible to Syringe Service Programs, first responders and law enforcement, and community organizations, by request. In the past year, these state partners has distributed over 68,000 free units of naloxone across the state. "Naloxone is available in a variety of settings – but many Kentuckians still face the barrier of cost when obtaining the medication at a pharmacy," said Dr. Marks. "This program is designed to ease that burden and encourage more Kentuckians carry naloxone." The naloxone co-pay program is intended for individuals enrolled in private health insurance plans that do not fully cover the costs of the medication. Federally funded programs such as Medicaid and Medicare are prohibited by law from the use of programs such as this. Data Update

KY SOS continues to encourage all facilities to submit their monthly data into KY Quality Counts (KQC). Please continue to report <u>monthly</u> data on both the process and outcomes measures. The Happenings

As a reminder for the Hospital Rate Improvement Program (HRIP), the Opioid Provider Education goal is that 90% of inpatient providers receive opioid best practice education in 2022. One way this can be accomplished is by providers attending the KY SOS educational webinars (current and previous). For past webinars visit: www.kentuckysos.com Go to education/events tab and click on past presentations.

The HRIP program does not specify how many hours a provider must attend or how they receive the education (in-person or webinar, etc.), only that the facility must have documentation that the provider received education in 2022.

During the 4th Quarter 2022, KY SOS will have a one-time metric in Kentucky Quality Counts (KQC) with a numerator of total number of inpatient providers who received education for opioid best practices over the denominator of total number of inpatient providers. If the hospital has 90% or greater they will receive the 0.5% designated funding for the HRIP metric.
