#### Kentucky Statewide Opioid Stewardship (KY SOS) January Newsletter

The Kentucky Hospital Association (KHA) and the Kentucky Statewide Opioid Stewardship (KY SOS) program are responding to Kentucky's current opioid crisis by meeting pharmacists where you are with your opioid stewardship programs. We recognize the need for further education in implementation of opioid stewardship programs in both inpatient and outpatient settings. Fundamental needs have to be met before we can see improvement with the opioid crisis. KY SOS believes further education of our healthcare providers is the key to attain this improvement across the state. The underlying question being how to manage pain in our patients while avoiding the risk of addiction.

Together KHA and the KY SOS program with the American Society of Health-system Pharmacists (ASHP) want to extend the opportunity for you as a **pharmacist or pharmacy resident** to complete the ASHP Opioid Stewardship Certificate. KY SOS program will sponsor 25 pharmacists in the completion of this self-guided, online program. This is a \$545 GIFT from KY SOS to complete this program! The program consists of recorded presentations, readings, and practice activities. Topics emphasized in this program include:

- Methods for developing an opioid stewardship program from its infancy through maturity and quality improvement.
- Strategies for creating executive leadership support and practitioner buy-in.
- Using data and metrics to inform program development, quality improvement, and management.
- Methods for educating the healthcare team and patients, and patient care strategies that identify and mitigate risks while incorporating shared decision-making with patients and/or caregivers.

Once the curriculum has been completed, the pharmacist will need to successfully complete a 100 question exam (scoring 80% or greater) to obtain the ASHP Opioid Stewardship Certificate. We encourage you to register today by emailing Stacy Allen at: <u>sallen@kyha.com</u>. The first 25 pharmacists to respond will be selected (we will limit the number of pharmacists from each facility to allow more hospitals to participate). After 25 have been selected, you will be placed on a waiting list for future groups. The success of this program will determine future sponsorship for this certificate.

KHA and the KY SOS program are committed to furthering education in opioid stewardship. Let's partner together to continue to reduce opioid overprescribing while improving safe opioid use across Kentucky. KY SOS program goals are for hospitals to demonstrate their actions and commitments to their patients and communities to combat Kentucky's opioid epidemic.

<u>FindRecoveryHousingNowKY.org</u> is a free near-real-time recovery housing locator and resource library for the state of Kentucky. The website launched on Wednesday, September 28, 2022. FindRecoveryHousingNowKY.org allows hospital staff and clinicians to locate available recovery housing openings for patients who are seeking safe and affordable housing that supports their recovery from substance use disorder (SUD). A simple search can be completed within one minute. More than 40 filters are available to help narrow down a search.

FindRecoveryHousingNowKY.org also provides a guided search tool for those who are not sure what they are looking for. The tool asks the website searcher a series of questions and provides a list of recovery houses based on the searcher's responses. The online library has resources on how to obtain a driver's license/identification card, health insurance, and food benefits, as well as on various support services. FindRecoveryHousingNowkY.org also has materials such as brochures, pocket cards, stickers, and magnets that can be ordered and mailed at <u>no cost</u>. Much like its sister site <u>FindHelpNowKY.org</u>, a free near-real-time substance use disorder treatment locator, FindRecoveryHousingNowKY.org is a linkage to care component for individuals with SUD. <u>FindHelpNowKY.org</u> launched in 2018 and has more than 700 SUD treatment facilities and over 300 providers listed on the site.

#### Key Messages from CDC Clinical Practice Guideline for Prescribing Opioids for Pain, 2022

#### Patients with pain should receive safe, effective, and informed pain care.

- Pain is a complex health issue and is influenced by many factors, including biological, psychological, and social factors.
- A variety of treatment options should be available and accessible for patients with pain.
- The 2022 Clinical Practice Guideline is a clinical tool to support <u>clinicians</u> and <u>patients</u> as they work together to create and maintain safe, consistent, and effective pain treatment plans.

The <u>CDC Clinical Practice Guideline for Prescribing Opioids for Pain–United</u> <u>States, 2022</u> (2022 Clinical Practice Guideline) provides 12 evidence-based recommendations for primary care and other clinicians who provide pain care, including those prescribing opioids, for outpatients aged 18 years and older with:

- Acute pain (duration less than 1 month)
- Subacute pain (duration of 1-3 months)
- Chronic pain (duration of 3 months or more)

The 2022 Clinical Practice Guideline **is not applicable** to management of pain related to sickle cell disease, management of cancer-related pain, palliative care, or end-of-life care. Other guidelines and recommendations have been developed by professional societies to guide pain care decisions for these conditions.

#### The 2022 Clinical Practice Guideline:

- Provides evidence-based recommendations to clinicians who provide care to patients with pain.
- Emphasizes that **shared decision-making** by patients and clinicians is critical.
- Aims to ensure equitable access to effective, informed, individualized, and safe pain management that improves patients' function and quality of life.
- Has been updated and expanded to address different types of pain and help clinicians and patients weigh the benefits and risks of a full range of pain treatment options, including prescription opioids.

## The twelve recommendations in the 2022 Clinical Practice Guideline address the following four areas:

- Determining whether or not to initiate opioids for pain (Recommendations 1, 2)
- Selecting opioids and determining opioid dosages (Recommendations 3, 4, 5)
- Deciding duration of initial opioid prescription and conducting follow-up (Recommendations 6, 7), and
- Assessing risk and addressing potential harms of opioid use (Recommendations 8, 9, 10, 11, 12)

The 2022 Clinical Practice Guideline was developed using the best available scientific evidence and followed a rigorous scientific process. The process included several opportunities for community and partner engagement. CDC highly values public engagement and has ensured there were multiple opportunities to hear from and incorporate feedback from patients with pain, caregivers, clinicians, and partners.

- Sources of input used to inform the development of the Clinical Practice Guideline include
  - New scientific evidence from systematic reviews
  - Community engagement to better understand the experiences of patients living with pain, their caregivers, and clinicians who provide pain care
  - Federal advisory committee engagement through the Board of Scientific Counselors of the National Center for Injury Prevention and Control (BSC/NCIPC) and the Opioid Workgroup (OWG)
  - Federal partner engagement
  - Public comment during public BSC/NCIPC meetings and during the 60-day public comment period on the draft updated Guideline
  - Peer review by external subject matter experts

**The recommendations are intended to support, not replace, care that is individualized, flexible, and patient-centered**. The Clinical Practice Guideline is not a regulation or a law. It should not be used as a rigid standard of care or inflexible, one-size-fits-all policy or law. It is a set of voluntary recommendations intended to support clinicians as they work in consultation with their patients to address pain. This publication updates and replaces the *CDC Guideline for Prescribing Opioids for Chronic Pain* released in 2016.

#### **The Happenings**

As a reminder for the Hospital Rate Improvement Program (HRIP), the Opioid Provider Education goal is that **90%** of **inpatient** providers receive opioid best practice education in 2022.

KY SOS will have a one-time metric in Kentucky Quality Counts (KQC) with a numerator of total number of **inpatient providers** who received education for opioid best practices over the denominator of total number of **inpatient providers** for 2022. Beginning **January 1, 2023**, you will be able to enter this data on the Data Entry page of KQC website. If the hospital has **90% or greater** they will receive the **0.5% designated funding for the HRIP metric**. To access your facility's dashboard:
