Primary Care Clinic Outpatient Program

You are aware of the extensive inpatient work around opioid stewardship since the inception of the KY SOS program, but are you aware the program is growing to include hospital owned primary care clinics?

The Cabinet for Health and Family Services approached KHA to expand its bandwidth and provide education and guidance in opioid stewardship to primary care clinics. The suggested program, called *Six Building Blocks* (6BB), was created by a physician-led multidisciplinary team from the University Of Washington Department Of Family Medicine and the Kaiser Permanente Washington Health Research Institute. The 6BB Program is a team-based approach to improving opioid management in primary care. In its entirety, the 6BB Program is a 9-to-12-month commitment for primary care clinics. This program is a "clinic redesign" with goals to consistently treat chronic pain patients on long-term opioid therapy in accordance with evidence-based

clinical practice guidelines. Information about the 6BB Program can be found on the website: https://familymedicine.uw.edu/improvingopioidcare/.

The Six Building Blocks are as follows:

- Leadership and Consensus-Demonstrate leadership support and build organization—wide consensus to prioritize more selective and cautious opioid prescribing. Solicit and respond to feedback.
- 2. **Policies, Patient Agreements and Workflows**-Revise, align, and implement clinic policies, patient agreements, and workflows for health care team members to improve opioid prescribing and care of patients with chronic pain.
- 3. **Tracking and Monitoring Patient Care**-Implement proactive population management before, during, and between clinic visits of all patients on long-term opioid therapy. Develop tracking systems; track patient care.
- 4. **Planned, Patient-Centered Visits**-Prepare and plan for the clinic visits of all patients on long- term opioid therapy. Support patient-centered, empathetic communication for care of patients on long-term opioid therapy. Develop, train staff, and implement workflows and tools; develop patient outreach and education.
- 5. Caring for Patients with Complex Needs-Develop policies and resources to ensure that patients who develop opioid use disorder (OUD) and/or who need mental/behavioral health resources are identified and provided with appropriate care, either in the primary care setting or by outside referral. Implement assessment tools; identify and connect to resources for complex patients.
- 6. **Measuring Success**-Identify milestones and monitor progress. Measure success and continue improving with experience.

Appalachian Regional Healthcare (ARH) has been the first health system to implement this important program. As the pilot health system, the 6BB program is currently in the process of implementation into clinics in the Hazard, Whitesburg and Prestonsburg areas. After policy and workflow changes have been made in these pilot clinics, work will continue in the remaining ARH primary care clinics. Thank you to ARH for piloting this 6BB program!

The goal for this 6BB Program is to be implemented across the state. Clinics are currently being recruited to implement the outpatient work. KY SOS is excited to announce TJ Regional Health has just committed to participating in the 6BB program in all 8 clinics. Thanks to TJ Regional Health for your commitment to improve opioid stewardship efforts in the outpatient clinics in your area. Ongoing recruitment and education of this program is a priority of the KY SOS program. Reducing opioid overprescribing while improving safe opioid use in inpatient and primary care clinics in Kentucky continues to be the KY SOS mainstay and goal. <u>FindRecoveryHousingNowKY.org</u> is a free near-real-time recovery housing locator and resource library for the state of Kentucky. The website launched on Wednesday, September 28, 2022. FindRecoveryHousingNowKY.org allows hospital staff and clinicians to locate available recovery housing openings for patients who are seeking safe and affordable housing that supports their recovery from substance use disorder (SUD). A simple search can be completed within one minute. More than 40 filters are available to help narrow down a search.

FindRecoveryHousingNowKY.org also provides a guided search tool for those who are not sure what they are looking for. The tool asks the website searcher a series of questions and provides a list of recovery houses based on the searcher's responses. The online library has resources on how to obtain a driver's license/identification card, health insurance, and food benefits, as well as on various support services. FindRecoveryHousingNowkY.org also has materials such as brochures, pocket cards, stickers, and magnets that can be ordered and mailed at <u>no cost</u>. Much like its sister site FindHelpNowKY.org, a free near-real-time substance use disorder treatment locator, FindRecoveryHousingNowKY.org is a linkage to care component for individuals with SUD. FindHelpNowKY.org launched in 2018 and has more than 700 SUD treatment facilities and over 300 providers listed on the site.

ECHO

Another learning opportunity is available for your facility. The Kentucky Hospital Association (KHA) and the KY Statewide Opioid Stewardship (KY SOS) program are delighted to be collaborating with partners at the University of New Mexico (UNM) ECHO Institute and the Centers for Disease Control and Prevention (CDC) to bring an active learning opportunity to KY facilities. This program is free of charge to clinicians and CEUs are available. UNM's TeleECHO Program will partner alongside you in a six week learning opportunity. The TeleECHO session requirements will consist of attendance in a weekly, one hour meeting via webinar. Each clinician is encouraged to submit a case presentation which may be selected for discussion during the session. The clinician will learn with a multidisciplinary team led by UNM faculty and consultants specializing in pain and addiction medicine. Subject matter experts from CDC and UNM's ECHO Institute will be on the webinar to help guide the treatment options. You will have the opportunity to ask questions, make suggestions and recommendations to impact patient care. The learner will increase knowledge in caring for patients with substance use disorder (SUD), chronic pain, and/or mental health concerns. Another added benefit to participation is increased confidence in providing aid to the "displaced" chronic opioid patient. Participation in this six week program will also fulfill Hospital Rate Improvement Program (HRIP) requirements for provider education on best practices in opioid stewardship.

ECHO Curriculum:

- 1. Safely Caring for Patients with Chronic Pain and Substance Use Disorder
- 2. Epidemics of Chronic Pain, Substance Use Disorder and Mental Health in the U.S.
- 3. Medications for Chronic Pain
- 4. How to Taper Opioids
- 5. How to Taper Benzodiazepines
- 6. Medications for Opioid Use Disorder

The first cohort began **August 31, 2022** and was a great success with many accolades from participants. The second cohort is scheduled to begin **October 11, 2022**. The Happenings

As a reminder for the Hospital Rate Improvement Program (HRIP), the Opioid Provider Education goal is that 90% of inpatient providers receive opioid best practice education in 2022. One way this can be accomplished is by providers attending the KY SOS educational webinars (current and previous). For past webinars visit: www.kentuckysos.com Go to education/events tab and click on past presentations.

The HRIP program does not specify how many hours a provider must attend or how they receive the education (in-person or webinar, etc.), only that the facility must have documentation that the provider received education in 2022.

During the 4th Quarter 2022, KY SOS will have a one-time metric in Kentucky Quality Counts (KQC) with a numerator of total number of inpatient providers who received education for opioid best practices over the denominator of total number of inpatient providers. If the hospital has 90% or greater they will receive the 0.5% designated funding for the HRIP metric.

October 29, 2022 National Prescription Drug Take Back Day 10am -2pm

Keep them safe. Clean them out. Take them back. The US Drug Enforcement Administration (DEA) promotes this biannual National Prescription Take Back campaign, occurring every April and October. This initiative allows for safe and anonymous means to dispose of unused or expired prescription medications in law enforcement locations all over the United States. There is hope that by the removal of these medications from homes all across the nation, it will lessen the potential for pollution, environmental effects impacting public health, as well as greatly decreasing the potential of misuse and possible tragic outcomes when found in the wrong hands, such as children, pets and teens or adults. It may very well be the first line of defense, for some, in the prevention of opioid addiction, overdose and overdose deaths. By going to www.dea.gov/takebackday, those interested can search for collection sites nearest to their chosen location. For those who may not be able to make it on October 29th, there are at least 193 permanent prescription drug disposal locations in Kentucky that offer year round services for medication disposal. Kentucky locations by county can be found on the Kentucky Office of Drug Control Policy website (Prescription Drug Disposal Locations - Office of Drug Control Policy (ky.gov). Your local waste disposal provider may offer guidance on how to properly dispose of medications if unable to attend a take back event and there is an FDA approved flush list that is used only as a next best option for potentially dangerous drugs that, for some, may be harmful with even a single dose (Drug Disposal: FDA's Flush List for Certain Medicines | FDA).

So how and where can you promote proper medication disposal in the workplace, home or community? Maybe it is simply taking inventory of your personal medicine cabinet at home or those of extended family. Maybe it is incorporating disposal training and education with your patients at discharge. Wherever that may be, as one large team, protecting our fellow citizens, patients, family, and environment, we can spread the word regarding safe medication handling.

Celebrating Recovery in Frankfort. September was celebrated as National Recovery Month. It was a time to celebrate those who have achieved recovery and for those individuals and families impacted by substance use disorders. KY SOS continues to provide an evidence-based standard of care and educational opportunities for those involved in the treatment of pain management to ultimately decrease misuse, overdoses and overdose deaths seen all too much in our state of Kentucky. It is the desire of KHA and KY SOS, to reduce opioid overprescribing, improve safe

opioid use, and to provide mechanisms for hospitals to demonstrate their actions and commitment to their patients and communities to combat the state's opioid epidemic.
